- Vehicles will have limited access to exhibit area, therefore exhibitors should be prepared
 to carry materials and equipment a short distance. Vehicles will be allowed to unload at
 exhibit space but should be removed immediately.
- Registration will begin on Friday and Saturday from 12:00 p.m. 4:30 p.m.
- This is a family event and all vendors must be family friendly. The Director of the Event shall have the sole discretion to require the removal of any item, which he or she determines violates the Rodeo's rules.
